Montford Point Marine Birthday Ball

In 1942, President Roosevelt and Congress established a Presidential directive giving African Americans/Blacks an opportunity to be recruited into the military. The African Americans/Blacks who wanted to be Marines were sent to Montford Point for boot camp. (At that time African Americans/Blacks recruits were not allowed to train with White recruits. Montford Point is now Camp Johnson, where Marine Corps Combat Service Support School (MCCSSS) calls home, and is a part of Camp Lejeune.) Approximately 23,000 African Americans/Blacks became Marines from 1942 to 1949, and they were called Montford Point Marines. These Marines blazed a trail for others to follow and are a part of our Corps' history.

In 1965, an enterprising group of Marine veterans residing in Philadelphia, PA, formulated and developed plans to hold a national reunion of the Montford Point Marines. Due to the great response to the reunion, the Montford Point Marine Association (MPMA) was formed. The sixth chapter of the MPMA was established in Washington, D. C. The District of Columbia Montford Point Marine Association Chapter #6 works cooperatively with local and national community organizations, working within the community to assure all veterans and their families a better life.

Each year MPMA Chapter #6 holds a Marine Corps Ball to celebrate the birth of our Corps. This year the 226th Birthday Ball was held on Friday, 16 November, at the Andrews Air Force Base Officer's Club. Lieutenant General Robert Magnus, Deputy Commandant for Programs and Resources, Headquarters, United States Marine Corps was the guest speaker.

CLARIFICATIONS REF FLU VACCINES

The Naval Medical Clinic Quantico has a limited supply of flu vaccine, which will be provided according to a prioritization plan. Active duty personnel, and beneficiaries identified as high risk for illness (e.g. elderly, individuals with weakened immune systems, etc.) have top priority.

The general family member population will not be immunized until all active duty units and highrisk individuals have been given an opportunity. Naval Medical Clinic Quantico will not be vaccinating GS workers. Civil service personnel and civilian contractors are advised to contact the healthcare system provided by their health plan for flu vaccination. Anyone under the age of 18 must have a prescription to receive this vaccine.

The Preventive Medicine Department is coordinating all active duty immunizations on a unit-by-unit basis. Base commands have been contacted and a vaccination schedule is being finalized. Powers of Attorney Sometimes Necessary in Military Life

WASHINGTON, Sept. 19, 2001-- There are many occasions during the course of a military career that a power of attorney might be necessary. But, legal experts caution, do your homework before granting one to somebody.

"Typically, service members will need a power of attorney when they may be deploying or going overseas and leaving their loved ones behind to handle the affairs of the household," Navy Lt. Joan Malik said. Malik is a legal assistance attorney in the Pentagon's Joint Service Legal Assistance Office.

There are two basic types of power of attorney, special and general. A general power of attorney basically gives the person who holds it the power to conduct business in your name, Malik said.

Service members can grant a special qwer of attorney, which spells out the specific ways it can be used. She said the more specific a power of attorney is the better. This prevents people from using it for purposes other than those the service member intended.

"Don't give a general power ofattorney to someone you don't trust wholeheartedly," she said. Base legal assistance attorneys can help service members determine which type of power of attorney will best meet their needs.

Service members commonly need to issue powers of attorney when hey change assignments. They often leave their spouses behind to sell cars, move out of government quarters and myriad other things. Those spouses often need legal authorization to conduct the necessary business.

Service members may also need a power of attorney to provide the person caring for their dependent children during a deployment or exercise. Caregivers may need a power of attorney to enroll children in school or other activities, Malik said. Caregivers would particularly need a power of attorneyto authorize medical treatment if a child needs it, she said.

Medical powers of attorney are used if a person becomes incapacitated and someone else needs to make medical decisions. "This document designates who you want to speak on your behalf regardingyour care," Malik said. She suggested sitting down with the person who holds your power of attorney to make sure they understand your wishes in different circumstances.

Generally, Malik explained, powers of attorney are granted for one year. She said a member could revoke a power of attorney in two ways if circumstances change.

The first and simpler is to physically destroy the original document, Malik said.

The second is to write a letter of revocation, have it notarized and send a copy to the person hdding the power of attorney. It's best to also send a copy of the revocation to places where the person is likely to use the power of attorney, such as banks or moving companies.

Military service members and their families can have powers of attorney drawn up and notarized at most base legal assistance offices. Malik recommended troops call their legal assistance office if they have any questions about powers of attorney.
